The French Market is a juried/invitational show featuring artists from Ohio and surrounding states selling their original works. The Market will be held at Todaro's Party Center in the Cuyahoga Valley, a beautiful suburb of Akron, Ohio. Every effort will be made to insure that the show is well balanced. Witan is a self-sustaining, non-profit organization and has donated over \$1,000,000 to community agencies.

**Artists must provide their own 3-sided booths, tables, drapes, and screening so that adjoining booths are not visible. The appearance of your booth is important! We can provide pipe and drapes for an additional fee.**

### **Jury Requirements:**

Submit by e-mail four (4) digital color photographs of your current work and booth to [jhwitanmarket@sbcglobal.net](mailto:jhwitanmarket@sbcglobal.net). All work must be of fine quality and the original work of the applicant. No commercially manufactured items will be permitted. (See application for submission guidelines)

### **Jury Fee:**

A non-refundable jury fee of \$5 payable to Witan, as well as a self-addressed stamped envelope with appropriate postage must be included with your application.

### **Display:**

Work displayed at this show must be in the categories in which the artist was juried. You cannot, for example, gain acceptance with the photos showing decorative pottery and offer for sale ceramic jewelry. All work must be comparable to the work shown in your photos. ***All prices must be clearly marked.***
